- ◆ ATM transactions at Progressive Bank ATMs *at no cost*
- ◆ E-Statements are standard with **New Start**
- ◆ Online Banking *at no cost*
- ◆ **NO CHECKS and NO OVERDRAFT PRIVILEGE**

PROGRESSIVE CHECKING

- ◆ Available to individuals, nonprofit organizations, and churches
- ◆ \$100 minimum to open
- ◆ Monthly Balance and Service Charge schedule:

<i>\$800 and above</i>	<i>No service charge</i>
<i>\$500—\$799.99</i>	<i>\$8</i>
<i>\$350—\$499.99</i>	<i>\$9</i>
<i>Below \$350</i>	<i>\$10</i>
- ◆ Electronic transactions *at no cost*
- ◆ First 15 checks or other non-electronic withdrawals per month are *at no cost*
- ◆ 12¢ per check/non-electronic withdrawal above 15 per month (this charge is waived if average daily balance is \$1,500 or more)
- ◆ 25¢ per item deposited above 20 per month

INTEREST (NOW) CHECKING

- ◆ \$1,500 minimum to open
- ◆ No service charge for balances of \$1,500 and above
- ◆ \$12 service charge for balances below \$1,500
- ◆ First 15 checks or other non-electronic withdrawals per month are *at no cost*
- ◆ 12¢ per check/non-electronic withdrawal above 15 per month (this charge is waived if average daily balance is \$2,500 or more)
- ◆ 25¢ per item deposited above 20 per month
- ◆ Interest paid on balances of \$1,000 and above
- ◆ Check images provided in monthly statements and online
- ◆ Electronic transactions *at no cost*
- ◆ ATM/Debit Card⁺
- ◆ ATM transactions at Progressive Bank ATMs *at no cost*

TREASURY RATE CHECKING

Unlimited transaction account that may pay a higher rate-

- ◆ Available to individuals and nonprofit organizations
- ◆ \$5,000 minimum to open
- ◆ No service charge for balances of \$5,000 and above
- ◆ Service charge of \$25 plus 20¢ per withdrawal for balances below \$5,000
- ◆ 25¢ per item deposited above 20 per month
- ◆ *Treasury Rate* checks *at no cost*
- ◆ Check images provided in monthly statements & online
- ◆ Electronic transactions *at no cost*
- ◆ ATM/Debit Card⁺
- ◆ ATM transactions at Progressive Bank ATMs *at no cost*
- ◆ Online Banking and Online Bill Payer *at no cost*
- ◆ Interest Tiers:

<i>\$100,000 and above</i>	
<i>\$50,000—\$99,999.99</i>

Limited transaction account that earns money market rates-

 - ◆ \$2,000 minimum to open
 - ◆ No service charge for balances of \$2,500 and above
 - ◆ \$12 service charge for balances below \$2,500
 - ◆ Interest paid on balances of \$2,500 and above
 - ◆ \$10 Excessive Withdrawal Fee (for each non-personal withdrawal including check, draft, POS, or online
- transfer after 6 per month per federal regulation.)
 - ◆ 25¢ per item deposited above 20 per month
 - ◆ Check images provided in monthly statements and online
 - ◆ ATM/Debit Card⁺
 - ◆ ATM transactions at Progressive Bank ATMs *at no cost*
 - ◆ Online Banking and Online Bill Payer *at no cost*
 - ◆ \$800 Progressive Overdraft Privilege*

INVESTMENT MONEY MARKET CHECKING

Limited transaction account that may earn higher money market rates for higher balances-

- ◆ Available to individuals only
 - ◆ \$5,000 minimum to open
 - ◆ No service charge for balances of \$5,000 and above
 - ◆ \$15 service charge for balances below \$5,000
 - ◆ Interest paid on balances of \$5,000 and above
 - ◆ \$10 Excessive Withdrawal Fee (for each non-personal withdrawal including check, draft, POS, or online
- transfer after 6 per month per federal regulation.)
 - ◆ 25¢ per item deposited above 20 per month
 - ◆ Check images provided in monthly statements and online
 - ◆ ATM/Debit Card⁺
 - ◆ ATM transactions at Progressive Bank ATMs *at no cost*
 - ◆ Online Banking and Online Bill Payer *at no cost*
 - ◆ \$800 Progressive Overdraft Privilege*

PERSONAL SAVINGS SOLUTIONS

PROGRESSIVE SAVINGS

Regular savings for a rainy day!

- ◆ Available to individuals only
 - ◆ \$100 minimum to open
 - ◆ Fees waived for accountholders 17 and younger
 - ◆ \$2 service charge for every withdrawal over three (3) per calendar quarter regardless of balance
- ◆ 25¢ per item deposited over 20 per month
 - ◆ Limited by federal regulation to a maximum of six (6) transfers from savings in any 4 week period. Excessive Withdrawal Fee of \$10.00 each after six.
 - ◆ No service charge for balances above \$400. Quarterly service charge of \$12.00 for balances below \$400.

POWER SAVINGS

Earn even more money on your savings-

- ◆ Available to individuals only
 - ◆ \$100 minimum to open
 - ◆ Interest Tiers:
 - \$0- \$2,499.99 \$2,500- \$9,999.99
 - \$10,000- \$24,999.99 \$25,000 and above
 - ◆ \$2 service fee for every withdrawal over three (3) per calendar quarter regardless of balance
- ◆ 25¢ per item deposited over 20 per month
 - ◆ Limited by federal regulation to a maximum of six (6) transfers from savings in any 4 week period. Excessive Withdrawal Fee of \$10.00 each after six.
 - ◆ No service charge for balances above \$400. Quarterly service charge of \$12.00 for balances below \$400.
